Manners Please!

This facility is a wonderful, clean and friendly place with indoor bathrooms and very nice people. However, they are as careful with their horses as we are with our dogs. Please be ultra responsible about keeping your dogs away from any and all horses.. Crating area is adjacent to the ring. Belongings may be left overnight

Directions To Hidden Springs Stable

The trial will be held at 6005 McKendree Road, Lothian, MD 20711.

- If using MAPQUEST, put in **Dunkirk** instead of **Lothian**.
- FROM ROUTE 3: The objective is to reach the Lothian area, which is on the Eastern side of 3/301. Coming from North or South: Take Rt. 3/301 to Rt. 4 south to Rt. 258 east (Bay Front Rd.) to McKendree & turn right, then left into driveway.
- FROM RT. 2 - Go South until you reach the Lothian traffic circle. Go 3/4 of the way around the circle and continue on Rt. 2. At the first light, Rt. 258 (on the map, also called Bay Front Rd) turn right. Pass 2 churches on the right. Get into the left turn lane and turn left onto McKendree Rd. Turn left into the driveway and the indoor ring will be on your right at the top of hill.

Hotels/Motels

Please check with these motels to insure they still take dogs and by YOUR actions, insure that they continue to do so in the future. You need to insure that their pet policies have not changed.

- Forest Hills Hotel (Now Executive Inn), 301-627-3969
Located at 2901 Crain Hwy (Rt. 301), 2.5 miles north of Upper Marlboro. It's closest to the Lothian site, about 10 miles away. Price is around \$50 + \$5/dog/day. 13 units. It looks clean & well tended on outside. Older motel, may not have late check in.
Directions from to the trial site from here: take Rt. 301 south to Rt. 4 south to Rt. 258 east (Bay Front Road) to McKendree & turn right, then left into driveway.
- Days Inn, 301-932-9200
Located at 11370 Days Court, Waldorf (off Rt. 301). About 20 miles (?) from trial site.
Directions to the trial site from here: Take Rt. 301 north to Rt. 4 south to Rt. 258 west to McKendree, turn right, then left into driveway.
- EconoLodge, 301-645-0022
Located at 11770 Business Park Dr. Waldorf, (off 301). Same directions as Days Inn.

This is no overnight parking or camping on the show grounds – sorry!

Daily Fees And Package Rates

- Each individual round of agility - \$12
- Full weekend package (all 12 runs): first dog: \$112 – second dog, \$107 – third dog, \$102
- One day all 6 runs - \$60
- Return check fee - \$35
- **HOOPERS: If you were entered in Hoopers at our October 2009 trial, a class that was not run because no exhibitors wanted to run it due to the nasty weather conditions please take \$5 off of your entry fee with our compliments on your ever so correct decision not to run!**

Move-ups, Corrections, and Changes

You must send in all move-ups, corrections, and changes by Monday 1/25 at noon. We will also do move ups at the trial. When your confirmation letter arrives (confirmations are sent by e-mail shortly after being received with final confirmation being sent after closing) please read it carefully. We accept total responsibility for any and all errors made up to 1/25 at noon. After that, there will be no changes other than formal move-ups (between days) at the trial.

Notice To Exhibitors

Exhibitors through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations and agree to abide by all rules in effect at the time of the trial.

Dogs must be registered and have a valid registration number before entries will be accepted. Pending numbers are no longer accepted.

The current Jump Height Table, Breed Exemption List, description of classes, levels, and divisions are included in the current Exhibitors Handbook.

Seniors and handicapped handlers entering the Touch N Go, Weavers and Tunnelers classes please read: Veteran HANDLERS and handicapped handlers may be given 10% more course time for qualifying purposes only. They shall be placed with all dogs in their Standard division jump height. Handicapped handlers are required to send a copy of their handicap auto permit OR a letter from their physician.

Through submission of entry, exhibitors acknowledge they are familiar with the rules in the current Exhibitors Handbook.

THE MANAGEMENT will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee be asked to leave the show site. In such case, no refund of fees paid will be made.

IMPORTANT. Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC records trial results as they are submitted by the host clubs/groups. The individual trial results submitted by the club are uploaded to the files section of the NADACagility@yahoogleps.com list within two weeks after the NADAC office receives them from the club. The trial results will remain on the list for at least thirty (30) days. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the www.NADACagility@yahoogleps.com list and set your settings to "no mail". You will be able to view trial results and check for any possible discrepancies, without receiving list mail. If you find an error in the reporting of your dog's qualifying points or registration number, please contact the host club. The host club is responsible for correcting any errors and informing NADAC.

Levels. Points earned at a higher level of a class, prior to the completion of the lower level title, will not be banked by NADAC for future use. If a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

Trial Schedule

- **Check-in and Measuring** will begin at 7:30 (final confirmation may change this)
- **Walk through and briefing** will be as soon as possible after 7:30
- **Judging** will begin as soon as possible after walk through.

Workers Needed!

As always, we depend upon YOU and your fellow competitors to help run our trial. To make this easy, there will be a large Worker Schedule posted at the trial site where you can sign up to work the classes and jobs that YOU prefer to work! Remember, the Worker Schedule must be filled out and workers assigned before each class can begin. Thank you in advance for the generous contribution of your time and energy!

Club Policies

- All dogs must be on leash when not competing in the ring.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire an act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee including weather or other acts of nature.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$35 service charge for bank returned checks.
- Running order is determined alphabetically. Handlers with more than one dog in a class will be separated if possible.
- All dogs for a given class should be present at ring side at least one-half hour prior to the start of the scheduled classes for walk through and briefing. Any dog and handler not present when they are called will be ineligible to run.
- No Alcoholic Beverages are allowed on the show site.
- There will be no refunds for entries in the event a dog and/or handler are dismissed from competition regardless of the reason for such dismissal.

- A withdrawal from the competition after the closing date due to a bitch coming into season after the closing date will be eligible for a credit of 50% of the total entry fee paid to be used within 6 months at a future PAWZAZZ trial. A veterinarian's notice will be required for a credit.
- Ribbons will be awarded to first through fourth places in all jump heights in all classes and for qualifying.
- Note: there are no placement ribbons awarded for Chances as it is a pass/fail class.
- It is expected that owners of dogs who are extremely noisy or protective of their spaces will tent/crate away from high traffic areas and areas near the ring itself.
- No dogs may be chained or tethered at this trial. Please use crates , ex-pens or other suitable containment measures.
- **If you enclose a copy of your height card with your entry, you do not need to do check in at this trial. Skilled entrants do not need to be measured! If you have ever sent in a height card, there is no need to send in another copy.**
- Expecting that NADAC MAY require registration cards to be presented at some point in the future, you may also include a copy of your dog's registration card and we will put it on file.

AS OF JANUARY 1ST 2009, ALL DOGS ENTERED IN SKILLED ARE REQUIRED TO JUMP 4" LESS THAN THEIR REGULAR JUMP HEIGHT. There is no longer a 20" division for skilled dogs!

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1 As used here 'NADAC' means North American Dog Agility Council, Inc., its members, officers, directors, employees, show chairs, show committees and agents.

1.2 Exhibitor/owner, agree to abide by the rules and regulations of NADAC, and any other rules and regulations appearing in the premium for this event.

1.3 Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs, or property, has never been dismissed, excused or prohibited from entering any dog training class or event of any kind and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4 Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fitting, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5 Exhibitor/owner release NADAC (including NADAC officers, directors, employees, and members), KINDER-PUP, INC and TEAM PAWZAZZ (including its officers, directors, and members, and event organizing committee), Hidden Springs Stables(including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

1.6 Exhibitor understands there is a returned check fee of \$35. In consideration of the acceptance of the entry, I/we agree to abide by the rules and Regulations of NADAC in effect at the time of this trial, and by any additional rules and regulations as approved by the board of NADAC for this trial. I/We certify that the dog entered is not a hazard to persons or to other dogs. I/We further agree to be bound by the "Agreement" printed above.
